# School Board to institute "Distinguished Graduate Program"

At their monthly meeting last week the Columbus Community School Board formulated a new program designed to both recognize distinguished graduates of Columbus Community Schools, and also show the value one can receive from an education at Columbus Community.

"Columbus Community School believes that a Columbus education and diploma enables students to do great things. We believe that there are Columbus graduates who have done great things and they deserve recognition by Columbus for their achievements as adults," explained Superintendent Rich Bridenstine.

The idea of the program is for

the public to nominate worthy graduates for consideration. All nominations will then be considered by a committee, and a distinguished graduate will be selected each year to be honored at graduation ceremonies. Those distinguished graduates will then be added to a "Wall of Fame" in the school. The committee and parameters for qualification to serve are yet to be determined.

In order to be considered as a nominee, one must have graduated from either Columbus High School, Cotter High School or Conesville High School. They must have accomplished some item of significant achievement or contribution. Examples are achievements in career, country, community or service to

Any individual or group may make the nomination of a person. The nominations must be in writing and must include the individual's name, graduation year and profile of accomplishments. The nomination deadline is April 15, 2008, and inductions will occur during the High School graduation ceremony. The selection will be made by unanimous vote of the selection committee. An individual or group may nominate more than one candidate, and those individuals not chosen the first year will be automatically included with the group of nominees for the next year. Nomination forms will be available at both banks, the Columbus Gazette, City Hall and the Superintendent's Office. All nominations must be returned to the Superintendent's Office by April 15, 2008 to be considered for this year. "The Board's desire is to show new graduates what these individuals have accomplished in life, and to emphasize that they began their careers with the same item that the new graduates have, a Columbus Community diploma," said Bridenstine.

# City Council reviews request for additional sewage usage

A construction project by a Conesville family farming enterprise might lead to an increase in sewage treatment by Columbus Junction. Brad Bell told the city council at its February 13 meeting that his family was building a new facility in Conesville that would house up to 300 migrant farm workers, but the project would likely cause Conesville to exceed its sanitary sewer system's capacity because the family already houses around 450 workers in any building.

Bell asked the council if Columbus Junction would be willing to treat waste water that would be pumped from Conesville's lagoon once it reached its maximum capacity. Bell said the waste would likely be generated some during the late summer or early fall.

"Muscatine has agreed to take it, but Columbus Junction is closer," he told the council.

Environmental officials with the Iowa Department of Natural Resources told him the decision would be up to Columbus Junction, Bell explained, stressing the request to the city was from his family's enterprise and not the City of Conesville.

Columbus Junction officials said they estimated up to 30,000 gallons of additional waste water could be produced daily by the new workers, based on an average usage of 100 gallons per person. The city currently treats around 200,000 gallons of waste water each day. The officials said they would need to have an engineering study completed before committing to any action.

"You can be a good neighbor, but

you don't have to open yourself up to issues unnecessarily," Mayor Dan Wilson said.

Officials said that could happen if the additional waste products caused an increase in the city's biological monitors. The officials said the city must maintain certain monitoring levels and if the additional waste caused those levels to raise, Columbus Junction would have to face the consequences from state environmental officials and not the Bell family.

Bell said his family would be willing to fund an engineering study if necessary. Wilson told Bell to contact him if the family decided to pursue the matter.

In other action, the council briefly reviewed its proposed 2008-09 budget. The proposal includes \$1,275,861 in spending and \$1,281,003 in revenue. This year's figures included \$1,259,355 in expenditures. A public hearing on the proposal is scheduled for February

According to budget worksheets, the police department's budget is projected to be \$285,048, compared to this year's spending of \$258,577. Other 2008-09 department spending (with current spending in parenthesis) included the library, \$70,100 (\$65,091); parks and recreation, \$11,550 (\$13,450); mayor and council, \$8,612 (\$8,612); city hall, \$29,753 (\$25,200); water fund, \$247,150 (\$247,150); Road Use Tax, \$161,880 (\$160,360); solid waste, \$122,500 (\$120,500); sewer fund, \$178,600 (\$178,600) and miscellaneous, \$117,827 (\$156,685).

The miscellaneous fund included

TIF spending for Colonial Heights, debt service, community development and the city's share of revenue collected through the voter-approved 1% sales tax that will go for construction of a new Louisa County jail.

During the budget discussion, council member Mark Huston said the city council should begin to review its water rates.

"I think it's been about 10 years since we adjusted rates," he said.

In final action, the council also examined a bid for street repair work from Kluesner Construction, Inc., Farley, Iowa. The company submitted a \$3,623 bid to seal approximately 5,372 feet of cracks and joints on Colonial Avenue from Springer Street to the cul-de-sac. The company also submitted a \$5,980 bid for around 6600 feet of sealing and mill work on Main Street from the viaduct to Springer Street. Officials said the bid was considerably lower than earlier estimates.

Council members told city staff to obtain references for the company and additional formal bids from other providers and a final decision would be made after those were received.
