Local Health Facility turns 35 years old

The Columbus Medical Facility has now hit its thirty-fifth birthday. The whole process began with the following article in the May 27, 1976 Columbus Gazette:

The Columbus Community Medical Facilities Committee is in the process of being established as an arm of the Community Club. The Corporation is charged with the responsibility of establishing better medical services and a doctor's facility for the community.

The corporation was established by Jim Rutt, Max Quigley, Robert Hedemann, Bill Fulton, and Clyde Crawford, all members of the Doctor's Facility Steering Committee. Using seed money from proceeds raised during the community's centennial in 1974, the Medical Facilities Corporation was organized with Crawford, Fulton, Hedemann, Quigley, Rutt, Jay Schweitzer, and Lucile Smylie serving as the found-

Preliminary plans were drawn up for the building, and Mr. and Mrs. B.O. Roundy came forward and donated the land for the facility and generous cash donations were received from the Marie C. Letts Estate and from Mr. and Mrs. F.D. Smylie. Stock in the corporation was sold, various fund-raisers held, and Rath Packing employees gave over \$8,000.

Ground breaking took place in 1977 and Dr. Kenneth Carrell moved his offices into the facility in 1977. In 1987, an addition was added and Dr. Heather Heddens, DDS, moved her dental practice into one of the

The Board then saw a need for a facility to house a community ambulance service. In 1990 a separate ambulance garage and offices were

built adjacent to the city's water tower, and leased to the Louisa County Ambulance Services.

In 1999 long-time pharmacist Warren May retired from business and the community was without a pharmacy. An arrangement was made with Drug Town in Muscatine and eventually they leased the remaining wing of the facility. The pharmacy is now about eleven years old.

Unfortunately, in 2008, the Columbus Medical Facility was inundated with water from the June flood that year. Dr. Willy Wever, who was the dentist there at that time, chose to move his office after that tragedy. Fortunately, he still is in the Columbus area with his office now located in Columbus City. The Medical Facility was redone and the Drug Town Pharmacy added the space formerly occupied by Dr. Wever to their busi-


Currently the medical portion of the facility is now leased to Mercy Services of Iowa City. Dr. Brian Masonholder serves the medical needs of the community and Kelly Harris is the receptionist and medical clerk. Both Masonholder and Harris came to the clinic on July 21, 1980. These two now work with Twyla Carey and Char Mendenhall as nurses. Thelma Rutt was a longtime nurse there, and her family donated a P. Buckley Moss print that hangs in the outer office above the decorated tree.

The pharmacy has their own crew with Leah Willoz as pharmacist and Nancy Turner and Dee Anna Cutler as assistants. The three of them are kept very busy as demands are great. It is also wonderful that people can visit the doctor and walk right next door for their medications.

CJ Road Clean Up scheduled for April 14
