

Council delays action on liquor license request

There are some things that seem to make natural combinations, but a proposal to seek a liquor license for an auto parts store caused some bewilderment for Columbus Junction city officials during the city council's regular June 23rd meeting.

Mayor Dan Wilson reported that Antonio Sosa was applying for the license for his New York Dollar Auto Parts Store, which Wilson said Sosa planned to open in a building located south of the viaduct previously owned by Ross Masonholder. Wilson indicated the combination did not seem appropriate. "It seems like a strange combination (and) I have some concerns about a liquor license for an auto parts store," he told the council.

Sosa's identification on the liquor license application that the business would be a convenience store, created more uncertainty; as did the application's design plan, which included restaurant and bar facilities.

Wilson's concerns were shared by council members Phil Kaalberg and Hal Prior, who agreed the combination and the varying descriptions of the business left quite a few questions unanswered. "I'd like him to come to the council and explain," Kaalberg said, explaining Sosa's proposal could open the door for other unusual requests. "I'm not crazy setting a precedent," he said. Prior agreed he was not in any rush to see more places in the community selling liquor. "We're probably leading the state in per capita number of liquor licenses," he told the council, adding he did not favor granting a license for an auto parts store.

Council member Mark Huston wondered if the council's opinions would mean anything if it turned down Sosa's application. "He can appeal to the state," he pointed out.

Council member Curt Pierce also did not want to immediately turn thumbs down to Sosa's application, pointing out the location of the proposed business could help that area of town. "It would be nice to have it developed," he said, adding he was not eager to see more bars in the community. "We don't want a bunch of (bars) in town, but it is a nice business," he said.

Pierce's mild defense of the application led to some good-natured ribbing over his family's furniture and mortuary business. "I never understood how furniture and (funeral directors went together)," Prior said. "Yeah, but we never sold liquor," Pierce quickly replied. "Maybe (Sosa's proposal) is just ahead of its time," Huston added.

Wilson agreed the city needed to keep an open mind, but that would mean a better description of how Sosa intended to operate the new business. "We're not trying to step on any toes, but I think we need more information," he told the council. City clerk Julie Heindel said she would contact officials with the Iowa Alcoholic Beverage Division to discuss Sosa's application. The council agreed to table action on the application until Heindel reports on her query.

In other action, the council agreed to authorize Wilson to apply for funding to upgrade the city's levee system. City officials want to raise the existing levee to provide greater flood control on the Iowa River. However, a request for funds to the Iowa Department of Economic Development was turned down several months ago. Wilson has been seeking other potential funding sources and identified programs through the U.S. Department of Agriculture's Rural Services Agency and the State of Iowa IJobs Program as two potential funding sources.

"Sooner or later (the levee improvement) must be done," Wilson said, adding the recent rainy weather only increases the potential for new flooding. He said initial discussions with Rural Services personnel have been promising. Prior said the city needed to act. "The levee problem won't go away and I'd hate to have

(flooding) in a couple of years because we didn't apply," he said. Council member Dave Duncan agreed. "It doesn't cost anything to apply," he said. Wilson said he would continue researching the potential applications and would keep the city council informed on his actions.

The council also agreed to hire French-Reneker, Fairfield, to complete survey work on a property where the city intends to relocate its water treatment plant. The survey is expected to cost around \$2700. Wilson said the survey would provide officials with the Southeast Iowa Regional Planning Commission, which is handling the administration of nearly \$4 million in grant funding for the project, with the necessary information to move forward with land acquisition.

In final action, the council met with Jim Gabriel, chair of the city's new parks and recreation board to discuss possible recreation development projects in the community. "There are some really neat spots and we are in charge of keeping them looking good and making them better," he told the council. He pointed out the board was now investigating park rule signs, upgrading the new buyout properties along Fifth Street and other areas. Gabriel said that could include soccer fields, sand volleyball and basketball courts and other facilities.

The board also received a community development report from Nitza Lopez and assistant Nina Ortiz. The two updated the council on a new Spanish-language brochure recently completed by Jorge Malagon, Columbus High School Spanish teacher and his students. "It was something the kids wanted to do," Ortiz explained.

Other activities highlighted in their report included:

- * SRI grant, which provides training opportunities for Lopez and community development board director Mallory Smith;

- * Update on the farmers market and distribution of grant funds to vendors to improve signage and other marketing efforts;

- * Plans by Smith to meet July 8 with Southeast Iowa Regional Planning Commission officials to launch a Resource Enhancement and Protection grant application to fund park and trail improvements;

- * Working with several agencies to begin new English as a Second Language classes for the Burmese community;

- * Discussing business improvement ideas with the owners of the Columbus City market and Fulton Ct. Apartments;

- * Discussed with school officials possible community development programs that could complement the school's efforts to improve student achievement.
