

Over thirty years of dedicated service

For many years Columbus Community was the home and practice of Doctor Kenneth Carrell. He served the community along with his nurse, Thelma Rutt, who worked with Dr. Carrell from 1972 until his retirement July 18, 1980.

In 1976 meetings were organized with the objective of building a new Medical Facility. An organization was made formal and Board Members were composed.

For a small community to have the opportunity to house a second doctor and be able to keep providing medical care to its growing community was the original goal of the board members of the Columbus Medical Facilities Association, a non-profit corporation organized on May 28, 1976. A generous gift donated by Mr. and Mrs. B.O. Roundy provided the site located just east of what used to be the Columbus Laundry and Dry Cleaning and is now GIP'S for the medical facilities structure. The Medical Clinic was built in 1977.

When the Facilities Group learned that it was the beneficiary and recipient under the will of the late Marie Letts of Columbus Junction, they decided that an addition should be made to the medical facilities building with this gift along with the facilities' operating funds. Once again the Roundys donated the site for the new addition. Plans were then started to raise the funds to attract a second doctor to the community to work in the same practice as Doctor Carrell

The Medical Facility was fortunate to be able to recruit a familiar face to its staff, Dr. Brian Masonholder, DO, a family practice physician and also a former 1970 Columbus Community School graduate. 'Dr. Brian,' as he has been accustomed to being called, began practicing on July 21, 1980 and thus marks his 30th year in practice in his hometown community. After graduating from Columbus High School, Dr. Masonholder attended Coe College for two years, served in the Army for two years, and then received his degree at Cornell College and then attended COMS in Des Moines.

Dr. Brian lives in Columbus Junction with his wife, Jill. They have four children between them, Brad Masonholder and his wife, Erin

Kelly has served the Columbus Medical Facility for 30 years, beginning July 21, 1980. Her greeting has a soothing effect when we aren't feeling well, have a sick child or need to speak with a nurse or see the doctor. She has been like a security blanket to the patients that have trusted their care to the staff at the Columbus Medical Clinic. Kelly was a 1980 graduate of Columbus Community Schools and began working at the Medical Clinic right after graduating. Kelly resides in Columbus Junction with her husband, Terry Harris and daughter, Rachel, their daughter, Melissa lives in Coralville.

The Columbus Medical Clinic has had many employees over the years; Thelma Rutt remained at the clinic working with Dr. Masonholder until her retirement in 1999. These nurses have dedicated their time and affection to every patient, friend and community member that has sought treatment at their clinic.

Toolesboro Access closed
