Food, Fun and 4-H Youth Center



If you are looking for some fun and food this Saturday night, look no further than the American Legion building in Columbus Junction where the Louisa County 4-H and Fairboard are holding a soup supper, dessert auction, and "rock" auction. (These are two rocks donated by Kings Material, Inc. One is decorated for Iowa colors, the other for Iowa State).

County 4-Hers are working to raise money towards the Youth Center Building that is to be constructed at the Louisa County Fair Grounds. The cost of the new building is estimated at \$500,000. 4-H youth are working to help with this project in many ways, but one way is one dessert at a time. Following the soup supper this Saturday, there will be an auction of desserts provided by the 4-H families. Tessa Pugh, county 4-H coordinator, is hoping to have at least 150 desserts or more for the auction. The evening is scheduled for 5:00 p.m. to 7:00 p.m. with the auction starting at 6:00.

Just what is this new building? According to Bob Schlutz, Chairman of the Louisa County Fair Building Committee, floodwater over the years has done much damage to the fair buildings, but one wooden building in particular has been hard hit. This building is currently used for 4-H activities, miscellaneous meetings, and is the Fair Diner for food services. An alternative building needs to be considered to replace this building.

The new building would be located just north of the Variety Theater and measure 80 ft. x 96 ft. It



would consist of a 35 ft. X 80 ft. porch/patio area that would provide space for picnic tables, talent shows, 4-H events, and a senior citizen area. The porch area would be served by a pass-through window from the new kitchen that would provide food services. A congregate room (50 ft. X 60 ft.) would serve large parties, or functions (i.e. Habitat for Humanity dinners, cattlemen's functions and meetings, and 4-H exhibit hall for the fair). A pass-through window from the kitchen would also serve this area. The proposed building would have heating, air conditioning, and other essential services installed in the ceiling in case of high water.

Other details of the building that Schlutz cited are that it would be built at an increased elevation of 2.5 feet to protect against future rainwater flooding. The walls would be 10 feet in height and constructed of architectural decorative block to help eliminate damage from floodwaters. This would also reduce structural damage possibilities and allow for quick, ef-

fective cleanup if future floods were to occur. The city of Columbus Junction has been granted \$695,000 to raise the fairground levees to a level to help mitigate the flooding of the fairgrounds. The building would also include new restrooms and showers that would serve the campground area. This would be a great asset to the county, and the camp area at the Louisa County is the only fairgrounds camp with electrical services and wireless internet provided.

Schlutz reports that Casey's General Stores and Community Foundation of Louisa County each have committed to a \$50,000 donation toward this much-needed project. Muscatine Foods has committed \$25,000.

The people associated with the fairboard are really "gung-ho" about this project. Susan Pretz says, "I'm really excited; this is a big improvement for our fairgrounds. I'm hoping it will attract a new group of people to our fair." Bob Schlutz added, "The Louisa County Fair is an important part of our county. The

youth of tomorrow are the people who are going to inherit the benefits of this building. I believe that as we work together to make this happen, it is for the good of everyone in our county."
