More flood recovery steps fall into place

Another step forward to normalcy after the disastrous flood of 2008 took place last Monday as the Hy-Vee Pharmacy returned to their original location with a newly remodeled and expanded store.

The Hy-Vee Pharmacy has been temporarily located in the Iowa Telecom building while renovation of their former quarters in the Medical Facility building was underway.

The Pharmacy occupied the middle unit in the facility, with Dr. Wever occupying the east section. When Dr. Wever expressed an interest in exploring another location, the Pharmacy agreed to lease the additional floor space. The result is a new Pharmacy which has been expanded from 900 square feet to over 2,480 square feet.

Sewer problems plague City Council

Sewer backup problems in the south end of Columbus Junction might have several causes and a range of possible solutions, city officials were told during the council's November 12 regular meeting. Several city residents, including council member Hal Prior, have complained for several months about basement drains backing up and other problems. The council agreed to look into the problem after Keith and Cindy Milder, 101 Fulton Drive, complained in August about backup flooding in their basement.

The Milders had also reported problems in 1993 and 1996 and the city had conducted smoke tests and other inspections to try and identify illegal connections to the city's sewer lines. City officials said after those efforts were made there appeared to be a drop-off in problems until the recent complaints.

John Meyer, an engineer with French-Reneker Associates, Fairfield, who has worked with the city for several years on sewer, street and other improvements, told the council last week that he had inspected lines in the affected area and found some possible reasons for the backups. He also proposed several solutions, although he acknowledged a couple was unlikely because of their high cost.

Meyer said a major sewer line that runs from the end of Chautauqua Park all the way to Flatiron Drive has little change in elevation and can be quickly impacted by heavy rain events or other changing conditions...

"It's laid as flat as possible and any time there is a glitch, it can plug," he told the council.

He said Prior's house, which is located on Springer Avenue, is connected to the line and the flat grade and likelihood of plugs was probably the main reason for his problems.

"You need to put (the line) on a regular cleaning list and make sure it stays clean," Meyer told the council, explaining the lines should be cleaned once or twice a year. The city could also reduce the

flow going down the line by relocating a nearby lift station to a new site. That would divert some of the sewer flow to a different line. Neither the cleaning nor the relocation would require engineering or a major expense, Meyer assured the council.

The city could also conduct new smoke and other tests to learn how many residents have improper roof and drainage connections to the city's sanitary sewer system. Meyer said a single house roof connection is capable of overwhelming an eight-inch sewer line and causing backups. If there are several such connections, combined with sump pumps, line breaks and other infiltration problems, it would not take long for problems to develop.

Meyer said a solution to that problem was the key to solving the city's backups.

"The ultimate solution is to get rid of inflow and infiltration," he said.

City officials agreed that since the last testing in the mid-1990s, some residents could have made improper connections. Meyer said he would suspect any roof drains that went into the ground. He said the city could begin an inspection and ask property owner where those types of lines were present to show where the outlet was located. If the owner could not provide a site, it likely was emptying into the city's sewer line.

While cleaning lines, diverting to underused lines and disconnecting illegal drainage connections would be among the least costly efforts the city could do, probably totaling under \$20,000, another potential solution would have a much steeper price tag. Building a relief sewer line would likely cost around \$150,000, Meyer

City officials agreed the city should try the less expensive options first. City workers reported they had already arranged for the lines to be cleaned on November 13 and would also contact a crew to televise sections of sewer lines for breaks and other problems. Officials also pointed out problems might continue until soil conditions improve.

"The ground is so saturated, you get a rain and (backups) hit," council member Mark Huston said.

Officials said they would review conditions once some of the lines are

In other action, Mayor Dan Wilson warned the city would have much less salt to spread on city streets this winter and cautioned residents to exercise greater caution while driving. According to Wilson and public works staff members Fred Lukavsky and Jeff Carey, a salt shortage has hit the Midwest.

"We have been advised it will be difficult to get salt and driving conditions might be bad," Wilson said.

Lukavsky said snow removing teams spread nearly nine loads of salt, totaling around 225 tons, on city streets last year. However, the city currently only has one load of salt, about 25 tons, with the prospect of getting more slim.

"We're not going to be able to go overboard with salt," Wilson said.

Officials said they would likely focus any salting efforts on the Main Street hill to keep it open for fire and rescue equipment. They would use sand in other critical areas, such as intersections and steeper grades. Officials indicated they would not try to keep the Second Street hill open if heavy snowfall or other winter conditions developed.

In final action, the council approved the city's 2008 annual financial report. The report showed efforts to fight this summer's flood contributed to a \$2,988 deficit in the FY 08 budget's ending balance. The original projected balance had been \$90,350. City officials said they hope to recover the funding from FEMA and are expecting a \$148,000 reimbursement check this week.

The council also agreed to reschedule its next regular meeting from November 26, the day before Thanksgiving, to Monday, November

CJ Raceway becomes CJ Speedway

Changes are what race fans can expect for the 2009 racing season in Columbus Junction, Iowa. Long time promoters Jeff and Faith Story have handed over their promoters caps to Wapello residents Don and Sharon Wood and Brian and Amanda Tipps. On September 24, a three-year lease (with the option of three more years) has been signed between the Louisa County Fair Board and the Wood and Tipps families.

The new promoters have already begun their changes with a change from the name of CJ Raceway to "CJ Speedway." Vast improvements are planned for the fairground's facility to both the grandstand and track area with clean up of the facilities already underway.

Under the new promotion, the Wood/Tipps families hope to bring fans and cars back to this southeast Iowa track. With the improvements and their willingness to listen, they hope the Columbus Junction racetrack will be the place families will want to be on Friday nights. Already, area racers have committed to coming back to race at Louisa County's only racing facility.

Plans for the 2009 season, which is tentatively scheduled to begin in late April, will include five classes. 4 Cylinders, IMCA Stock Cars, Mod Lites, Hobby Stocks, and the new class for 2009 will be modifieds. The rules package will allow IMCA Mods and USRA Mods to compete against each other, scales have been purchased. Hopes of bringing motorcycle races and sprint car races are also being considered. Some fourcylinder specials may also be added later in the year along with some late model specials.

Races will continue to be held on Friday nights. Admission prices are tentatively being set at \$8.00 for adults, \$7.00 for seniors. Students 11-16 - \$6.00 and new next season will be kids 10 and under admitted free with paid adult. The popular Lil' Racers Car Club will also be coming to CJ for 2009.

Some of the previous track personnel will return but the new promoters are looking for some new faces including a flagman and announcer. The Wood/Tipps families hope that area businesses will join them in bringing a good quality show to the 4/10 mile with sponsorships and employee nights. Other possibilities to bring fans to the CJ Speedway will be "community nights", inviting area communities to enjoy the thrills of auto racing.

There is a lot of work ahead for the Wood and Tipps families before the start of the 2009 racing season, but with the support of family, friends and area communities, they are looking forward to their first year as pro-
