# Gazette Christmas Shopping Trip # 2

This week John and I hit some shops that offer diversity. You might say, "There is nothing for me there." But before you do, let me offer some personal anecdotes.

One is a story about a pinata. A few years ago when my daughter, Andrea, was still in college, I went to her yearly sorority fundraiser. The mothers came and brought things to auction, such as jewelry, luxurious towels, etc. I came with a colorful pinata and a basket full of Mexican food items purchased in Columbus Junction for my auction donation. I called it a "Mexican party." Before the auction, I heard many comments on it, such as, "How unusual!" or "Wouldn't this be fun!" The bidding on it was quite good, and the girl who got it said she was saving it for "finals week". She did, and Andrea reported the girls had a great time at the party. You don't have to be Mexican to buy a piñata.

Story two: Someone told us the jasmine rice at the Burmese Grocery Store, called Grace Chin, was the best they had ever had. I thought, "Rice is rice. What is the difference?" We bought and cooked some. It is the best rice I have ever had. It tastes great, stores well after having been cooked, and warms in the microwave quite well. We had an Oriental dish from it, but I want to try making some rice pudding. It is sold by the pound at Grace Chin. In fact, you can buy a 40-pound bag! However, it is now also sold by the amount you want. It is \$1.00 a pound. You don't have to be Burmese to buy here.

Story three: The Santa Ana Bakery makes specialty cakes for any occasion. John Carpenter ordered the birthday cake here for his wife, Donna's, big surprise birthday party that he had at the American Legion. It was very good cake and the baker took it to the Legion and set it up. These cakes are not just Mexican cakes—there are many different kinds, sizes, and prices. Prices run from \$20-\$100.

These three stories will hopefully lead you into reading all that is available at today's shopping list. Also, think in terms of your adult children and grandchildren if you have any, especially those who live out of town and may not have access to these items. Many people have become what is called "foodies." These are people who love to cook and love using unusual ingredients. Do you have any of these people in your family? Or people who are very health conscious? Then shopping in CJ may provide you many items to wrap as gifts this year and surprise your family members with the local fare.

We also visited two beauty shops. Great ideas for gifts abound here too!

**Tomato Fashion:** This store has unusual clothing, clothing that may not be found elsewhere. And here is the big news: The owner is wanting to get new inventory, so she wants

rid of all her items and is marking everything down to \$30 or below. What a deal! She has jewelry, clothing, purses, make-up, perfumes, accessories, etc. She has earrings that are only \$3.00. It is amazing what you can find here.

**Take 2 Video:** Of course there are movies galore here. But there is more. There are phones for sale—"I" wireless and accessories that go with them. This store advertises "the best burger in town", and the kids love them—this is the local "hang out" after school. There are booths for sitting or the old-fashioned soda fountain with stools. Tenderloins and cheese balls are also favorites. Think about gift certificates from here. These certificates are good for movies, food, and ice cream. The ice cream cones are huge. It also could be a fun night at home with movies and ordering the food to go. If you have family as guests, this would make an easy and cozy evening!

**Santa Ana Bakery:** As mentioned above, they have specialty cakes, but also much more. There are all kinds of baked goods, plus food and meals to eat in the store or to go. There are tacos, enchiladas, chimichangas, and homemade soups to name a few. Or get a breakfast and coffee here. The wall is lined with juices or pops to tickle your taste buds, and the homey atmosphere here is a lot of fun. There are gift certificates available and could be used to purchase food items or give a loved one "a meal out."

**New York Dollar Store:** This store has so much it is hard to know where to begin. They have piñatas on the top shelves, so "check these out." They have toys, clothes—two items often on many people's lists. They also have meat, food, cleaning products, and flavored drinks. There is a meat counter in the back. Most of all, they have many, many "little" items that would make great stocking stuffers. The owner runs a raffle where every certain-numbered customer gets a prize. You have to go in to see all that there is.

**Grace Chin Asian Store:** As mentioned before, they have the best rice here. They also have many different food items, clothes, blankets, and rugs. Yes rugs, and I love them! These are beautifully woven rugs in red, blue, green, with yellow, and these rugs are a really big size for an area rug. They are probably at least 8' by 10' and some are even bigger. They also could be used outside in good weather and would be a great addition to a patio setting. Some of the foods here are fresh, others canned or packaged. Some examples are Asian eggplant, Chana Dal split peas, Chinese doughnuts (good with coffee), Fried Chili Paste, Pickled Tamarind Leaves, Bamboo Shoots, fresh ginger, and Natural Palm Sugar (which is a candy).

**Rey de Reyes Mexican Store and Taqueria:** Once again, there are



so many items here, you need to go in to see. Let me name a few: spices; mole sauce; marinades for chicken, pork, and beef; beans; canned and fresh jalapeno peppers; sauces; Pacaya—date palm in brine; cookies; corn shells or banana leaves to wrap tamales; cheeses; meats; fresh fruits—granada, papaya, pineapples, and more. Also fresh vegetables, including green tomatoes for making salsa are here. In the back of the store is a small restaurant which serves tacos, quesadillas, burritos, enchiladas, sanchos, and more. This taqueria is open on Friday, Saturday, Sunday, and Tuesdays. Pinadas can also be purchased here.

**Special Effects:** This beauty shop does hair and nails. They also have a tanning bed and sell hair and nail products. They have gift certificates available for hair, tanning, or

products. Heidi Hartsock, who works there, said that a gift certificate can even be given for a certain number of weekly washes and sets—what a great idea for an elderly person or someone who regularly gets his/her hair done there! Any person would love this!

**Elvia's:** This, too, is a beauty shop. They do hair, give manicures and also give pedicures. A relaxing gift would be to get a gift certificate for all three, or at least two! What a gift! Total pampering!

That concludes this week's shopping trip. All of these stores are located on Main Street. There are gifts mentioned here for all ages and many "foodies." How surprised many of your children home from "the city" would be to find some of these gifts came from right here in Columbus Junction.

## City Council grants Fair Board flood plain variance

The Louisa County Fair Board will apparently only have to worry about climbing a fundraising mountain for its new youth center; and not literally build one on its grounds for the facility. The Columbus Junction City Council agreed at its November 23 meeting to grant a floodplain variance for the \$500,000 center to the fair board, which would allow the board to reduce how high it would need to elevate the building.

Fair board members Bob Schlutz and Bryan Townsley requested the variance, explaining without it floodplain regulations would require the new building to be substantially elevated. "It's in the floodplain so we need a variance unless we go up to elevation 588," Schlutz said, explaining that elevation would be about eight feet above the surrounding ground. "We plan to raise it two and half to three feet," he continued. Mayor Dan Wilson provided more detail on the city's floodplain regulations. Buildings in the floodplain must be one foot above the 100-year flood level. If the city receives a permit request that shows a building does not meet that elevation, the floodplain administrator cannot is-

sue a permit. Although the fair board's permit was still pending, Wilson said he expected city clerk Julie Heindel, who is also the city's floodplain administrator, to reject the request.

The council could take direct action because the city's floodplain regulations identify it as the government body with the power to grant floodplain variances. Wilson said a variance could be granted if a proposed building would not increase flooding or pose a public safety risk. Since the proposed youth center would not create either of those problems, Wilson said a variance could be granted.

Although the variance would mean the fair board would not need to build a mountain for the center, Schlutz acknowledged there was still a lot of fundraising to do before any construction could begin. According to the board members, about half of the funding has been raised, but another \$250,000 is still needed. The Community Foundation of Louisa County has contributed \$50,000 of the funds that have already been raised, with Casey's General Stores, Inc. pledging another \$50,000 over a five-year period. In addition to the

cash donations, Columbus Junction has offered around \$100,000 of in-kind sewer and water improvements.

Schlutz said the new building would use a unique combination of blocks, foam boards and thick concrete walls that would minimize damage from any future high water. He said the thick walls would also allow building to be used as a storm shelter. According to an earlier press release, the fair board was looking toward the future when it decided to seek a youth center at the fairgrounds. "County fairs are about continuing traditions, training tomorrow's agribusiness leaders and providing wholesome activities for families and friends to enjoy together. The Louisa County Fair Board is undertaking an expansion that will ensure their ability to do these things well into the future," the fair board explained in the October release.

The city's decision to upgrade the nearby Iowa River levee was an important factor in the fair board's decision to construct the building. The levee improvement is expected to provide increased flood protection to the fairgrounds and other low-lying properties in the east side of Columbus Junction. "We wouldn't be do-

ing something if you folks weren't going to be raising the levee," Schlutz said. Mayor Dan Wilson said bid letting on that project is expected to be held this February or March. That schedule appealed to Schlutz because of the fundraising mountain that still needed to be scaled. "It's a large figure, (and) we'll get it done; (but the center) is not going up until you get that levee done," Schlutz assured the council.

In other action, the council accepted a high bid of \$1265 for the sale of 42 trees in Chautauqua Park. The high bid was submitted by J. Kubitz Logging, Dubuque. White Logging Company, Edgewood, bid \$1160 for the trees; while Al Cole Logging, Strawberry Point, offered \$500. Wilson said the trees identified for cutting had been marked by Geode Forestry, Swedesburg. "The whole process will open things up," he said, explaining the city will be able to grow grass in some areas while neighboring trees that are in better shape will be released from the lost competition. Although the sale of the trees was approved, Wilson said he would confirm the logging company was properly licensed and bonded before any cutting occurs.
