State Bank reports on good year to Shareholders

"A very satisfactory year" was how Columbus Junction State Bank President Mark Huston described the bank's operations to shareholders last week. The bank reported net earnings after taxes of \$415,000, and showed asset growth of nearly \$2 million dollars. Loans increased by \$3 million dollars, with deposits showing a growth of over \$1 million dollars during the year. The Bank's primary capital was reported at 8.86%, well above regulatory requirements.

"In today's market, consumer lending remains flat as we are also

competing against dealer financing on bigger items," said Huston, "but we are open to any opportunities that come our way. I don't anticipate much change in this situation in the immediate future." The bank did have an opportunity to complete a large commercial loan this year, and does participate in the loan for the Assisted Living addition at Colonial Manor. Huston also commented that the farm economy had another good year with grain prices remaining strong, and he did not foresee any downturn this year. Huston reported that the bank has been able to avoid many of the problems that larger institutions have faced in the real es-

tate market because they are not interested in selling or buying real estate loans. "We have always emphasized single family real estate loans, and stick to traditional real estate guidelines, he said. Huston also stated that the bank has a very capable and stable staff. "Our good employees are one of our biggest assets," said Huston.

Chairman Tom Huston reported on major construction projects that are to be undertaken by the city and school. "We remain a progressive community, and these new projects are evidence of this. We are very proud of our town, and are anxious to help in any way we can."

The Stockholders voted to set the number of directors at seven, and re-elected Thomas H. Huston, T. Mark Huston, Kevin A. Van Heiden, C. Eugene Walker, Stephen Wilson, Larry Mincer and Daniel Wilson.

A Directors' meeting followed the annual meeting and the directors elected the following officers: Thomas H. Huston, Chairman and Trust Officer; T. Mark Huston, President and C.E.O.; Kevin Van Heiden, Vice President and Cashier; Tom Sands, Assistant Vice President and Loan Officer; Shelly Heindel, Assistant Cashier and Compliance Officer; Doris Mougin, Assistant Cashier; and Nancy Brown, Assistant Cashier.
